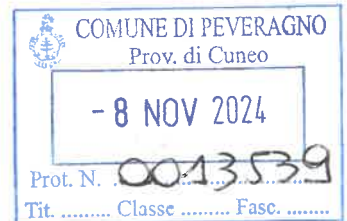

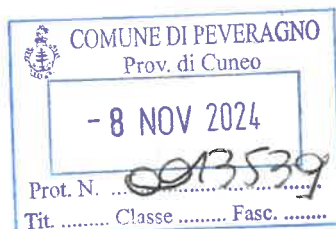

Elected jurisdiction: Jersey Trust Law (holding its own flag, state seal and sailing in international waters)

1) I, the Deponent, a living man (gender male), settlor, also perceived and recognized in the original phonetics in the organic body of male man **enrico**, as an individual who consciously uses the **Enrico Trustee Pellegrino** Diplomatic Body of STATE **PELLEGRINO™** "TRUST" alive and living from my origin, authentic genesis, xygote, oneness, in ownership and absolute power over all my parts⁹, in dominion of my own timeline¹⁰, fraudulently registered with birth certificate n° 389 Part 1 Series A/2 of 6/4/1976 **IK²⁶**, physically delivered on this earth (live birth and still living) after leaving my biological mother's womb on 05/04/1976 **IK²⁶** in CUNEO CN ITALY and with diplomatic seat established in VIA BRARD 26, PEVERAGNO (CN) - ITALY, aware that in case of false statement I will be subject to Universal Laws and current legislation on the subject and/or more favourable provisions;

IN-HONOUR-AND-TRUTH-I-DECLARE.

- 1) To claim and hold from the date above written "*Nunc pro tunc, praeterea proterea*" translated "now for then, hereafter" the quality of Sole and Exclusive Holder of the Right of Disposal over the TRUST having the same assonance of the name and surname chosen for me by my natural parents and pronounced in the sound of **Enrico - Pellegrino** ("Human Person"). Fraudulent TRUST created *Ex nihilo, Ems legis, in Corruptio legis* at registration at the general register office CUNEO (CN) - ITALY n° 389 Part 1 Series A/2 of 6/4/1976 **IK²⁶**.
- 2) To mandate the role of Trustee to the individual having LEGAL Personality and legal capacity by authority of the International LEGAL Personality named **Enrico Trustee Pellegrino** i.e. Trustee of the FICTION / LEGAL ENTITY / ASSET / VESSEL / HEAD OF IMPUTATION / FICTION / CESTUI-QUE-VIE and NATURAL Person/ or LIVING TRUST, in the following spellings: **PELLEGRINO ENRICO™** / **ENRICO PELLEGRINO™**, **Enrico PELLEGRINO** / **PELLEGRINO Enrico** created on 6/4/1976 **IK²⁶** in CUNEO (CN) - ITALY. This administration will include the F.C. PLLRNC76D05D205B™, SSN 80380000100131349653 and / or the identification documents referred to it including its related codes, expressed in alphanumeric strings, or expressed in magnetic stripe and / or any possible use of them in combination, in full and / or by segments of them and any other occult artefact, algorithms, biometric and / or IT applications equally created "*Ex nihilo, Ems legis, in Corruptio legis*" by ITALY REPUBLIC OF.
- 3) To establish the legal seat/registered office of the TRUST at SWISSMAILBOX - 931 RUE LE CORBUSIER 12 - GENEVA - SWITZERLAND. While the domicile is elected at the Trustee's PEC **enrico.trustee@pec.it**, email **enrico.trustee@pellegrino.protonmail.com** or TRUST office address;
- 4) To be the Trustee and custodian of the LEGAL POSITION segregated in TRUST, bearing SIGNATURE **ENRICO PELLEGRINO™**.
- 5) That I hold ownership of the LEGAL TITLE **ENRICO PELLEGRINO™** by proxy of this business to the human person, Individual subject to protection in International Law, by free and conscious choice, known as: man of the male gender: **enrico**, fraudulently registered as **ENRICO PELLEGRINO™**, physically delivered on this earth (live birth and still living) after leaving the womb of his natural mother named nicolella dynasty arnigo and from the father giuseppe offspring pellegrino;
- 6) To be the proposer¹¹ man in the male body of **enrico** in full power and absolute ownership of its parts, using the name **Enrico Trustee Pellegrino**, as Legal Representative, Trustee, of the FICTION or LEGAL ENTITY and the NATURAL Person AND the CENTRES OF JURIDICAL IMPUTATION segregated in this SWORN AFFIDAVIT ASSETS TRUST of high moral and humanitarian purpose as per the provision of the man (ref. Section A).



- 7) To be a "PROTECTED-PERSON" according to the "Geneva Convention for the Protection of Civilian Persons in Time of War" and especially to point "d)" of said Convention, concluded in Geneva on 12 August 1949, ratified in Italy by law no. 1739 of 27 October 1951 (in Supplement to the Official Journal, 1 March, n° 53).
- 8) To be the Sole and Exclusive Owner and Beneficiary of my own name and surname and of my pseudonyms as indicated above, of every artefact, including those created "*Ex nihilo, Ens legis, in Corruptio legis*" by the ITALY REPUBLIC OF *Et similia, et idem sonans* and produced without my written consent: wherever and however written, recorded, pronounced, according to the ITALIAN Civil Code. The exclusive ownership includes all Goods, properties as well as all elements constituting both material and moral value and recognised, registered or constituting, pertinent assets, equity. According to the provisions of Common Law, Natural Law, Inalienable Human Rights, the UCC Uniform Commercial Code and invoking the *Sui causae* from the provisions of generally known public and private international law treaties.
- 9) To be the Sole and Exclusive Holder and Guarantor of each name and surname conferred in this TRUST, to administer it/them applying where necessary the regulations of the CAVEAT (sex. 7)
- 10) To deny authorization to process the personal data of ENRICO PELLEGRINO™, PELLEGRINO ENRICO™, Enrico PELLEGRINO, PELLEGRINO Enrico, Enrico - Pellegrino and any other name segregated in this TRUST according to the directives set forth in the Positive Law, International Law, Community Law as well as in both privacy and UCC 1-308 section not expressly and formally ordered or authorized by the Settlor of the TRUST, who is fully exempt as well.
- 11) To INVALIDATE any contract/deed/agreement/signature, or effect of every contract/deed/agreement/signature entered into between/by/with the State "Italy", or the Corporation Republic of Italy and all its bodies, and any third party who, with wilful misconduct or not, prevaricates Enrico - Pellegrino: sole and exclusive owner and Settlor of the Right on the TRUST, totally exempt, including his person, his name, his pseudonyms, or every entity or imputation centres of relationships or legal statuses as indicated in points *Ut supra*, based on the precept "*Res inter alios acta tertiis neque nocet neque prodest*" translated "What has been negotiated between some does not harm and does not benefit others".
- 12) To be entitled under the law for the protection of the Human Person the right to Health Care and support in case of need, by means of the Contract/agreement formalized by the ITALY REPUBLIC OF without my consent, by which a collateral was issued by the FED Federal Reserve Bank, then held by the private company: BIS of Basel (Bank for the International Settlements) and on which various private companies speculate and do business and invest without my explicit authorization.
- 13) The qualification to drive the corresponding indicated by the driving licence of each class of vehicle, in total individual responsibility, as a Human Person (art. 13 UDHR Paris '48).
- 14) To order the rejection of all contract proposals in manifest dishonour, so I hereby deny consent to the proceedings without prejudice UCC § 1-103.

STATUTE "TRUST PELLEGRINO ENRICO™"

PACTA-INTER-VIVOS²⁵, MORTIS-CAUSA

Preamble

The Trustee in office is the sole custodian of the books belonging to the TRUST in respect of which he is bound by the duty of absolute confidentiality.

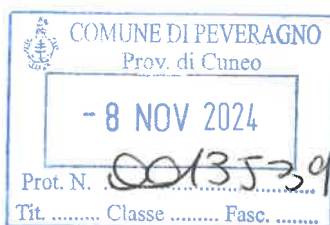
WHEREAS-THE-PARTIES

SETTLOR: The Settlor *enrico*, also called settlor, is the person who transfers his properties into this TRUST. Together with the Trustee, he draws up the TRUST regulations, which contain the lines of management, as well as the manner and timing of the transfer of assets and rights to the beneficiaries.

BENEFICIARIES: The beneficiaries of the TRUST are those to whom the benefits of the TRUST are directed. They are entitled:

- To know the existence of the TRUST,
- To know the documents of the TRUST,
- To have an account from the Trustee,

Hereinafter defined as: *enrico*, ENRICO PELLEGRINO™, PELLEGRINO ENRICO™, Enrico PELLEGRINO, PELLEGRINO Enrico, Enrico - Pellegrino



TRUSTEE:

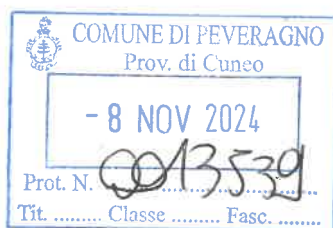
- a. The Trustee, currently identified with *Enrico Trustee Pellegrino* is the one who manages the assets transferred to the TRUST in the interest of the beneficiaries and pursues the purpose of the TRUST in accordance with the provisions of this Statute.
- b. Further Trustees can be appointed at settlor's request.

SUBJECT: it means any ownership wherever located and, when referring to rights or legal positions, such ownership includes those rights and legal positions regardless of whether they are due, subject to conditions, subject to termination conditions, or future conditions;

The "Settlor" *enrico* and the Trustee *Enrico Trustee Pellegrino* stipulate and establish the following

STATUTE:

- 1) The Preamble forms an integral and indispensable part of this STATUTE.
- 2) It is identified the "Status" of Pre-Juridical Entity of the Settlor *enrico* and the "STATUS" of Individual subject to protection in the International Law of the legal extension Being Human Person/Individual identified as *Enrico Trustee Pellegrino* according to the "Jersey Trust Law";
- 3) The living man of male gender *enrico* constitutes the "reaffirmation of pre-existence" (pre-legal Status) from which the existence of **PELEGRINO ENRICO™** illegally derives *Ex nihilo, Ens legis, in Corruptio legis* by the ITALIAN REPUBLIC Guarantor through the STATE ITALY EXECUTOR, to which consent was never given by the living man *enrico* and the basis on which the INTERDICTED LEGAL PERSON **PELEGRINO ENRICO™** now Beneficiary of the TRUST " **PELEGRINO ENRICO™**", functions as a means of contact/transmission, granting the Trustee the ability to interact, contract, exchange goods and services, trading with other LEGAL PERSONS and entities, created *Ex nihilo*¹⁴, *Ens legis*¹⁵, *in Corruptio legis*¹⁶ and/or other equivalent FOREIGN ENTITIES without being subject to any Positive Law and/or Legal Order, none excluded, subject to the Natural Law, including the intent/obligation to be in honour and which cannot abuse their power over *enrico* (Settlor), nor *Enrico Trustee Pellegrino* (Trustee);
- 4) *enrico* constitutes the source of the assets and values entrusted to **PELEGRINO ENRICO™** (originally incapable of understanding, willing and acting since constituted *ex nihilo, ens legis* and therefore having the physical form of a unilateral contract/agreement/signature, lacking the necessary consent of *Enrico Trustee Pellegrino*), through the sentient existence, exercise of faculties and work of the "Creditor" *enrico*, which provide the factors/cost values sufficient to support any contract/agreement/signature whatsoever that **PELEGRINO ENRICO™** can execute and by reference to which **PELEGRINO ENRICO™** can be deemed bound, no such binding is ascribable in the absence of consent drawn up and signed in by *Enrico Trustee Pellegrino*;
- 5) This statute constitutes an integral part of the ASSETS TRUST **PELEGRINO ENRICO™** and it must be clarified that the settlor of the TRUST himself is extraneous and superior as existing and living, to all Legal Orders due to his status of Pre-legal Entity, therefore tangible and never subject to creations, the work of fellows, to whom no conscious consent is granted/attributed, the work of a Pre-legal Entity therefore remains intangible, as long as he expresses itself in honour with our own kind.
- 6) The Settlers have decided to adopt the international law of Jersey (self-declared), as provided by Article 6 in the second chapter Applicable law of Convention on the Law Applicable to Trusts and on Their Recognition of July 1, 1985 Hague;
- 7) This TRUST will be given appropriate publicity through recognised means of notification, to the various ENTITIES of legitimate interest;
- 8) The present Deed is to be considered a FOREIGN TRUST in Foreign Representation of the LEGAL PERSON operating both in the National territory of ITALY and International territory;



9) PURPOSE-AND-ACTIVITIES-OF-TRUST.

- a) The purpose of the TRUST is the High Moral Purpose to promote, fulfil and protect the life and the existence of the beneficiaries of their own STATE and that of their descendants, to defend human rights in accordance with Natural Law, Commercial Law and Universal Law.
- b) All controversies can be refuted and archived by the pre-legal notary *enrico*. In the event of a legitimate need to remedy a dispute, the fund of reference is the human capital (Human Capital), i.e. the property of each man acting as a human being in unlimited quantity which cannot be confined by limits of any kind; for this recognised reality *Enrico - Pellegrino* is in Your definition. Bank, with unlimited capital and with a mandate to make any kind of payment, within your financial system, with scriptural money, originating from the "Human Capital" derived therefrom.
- c) ENRICO PELLEGRINO™ / PELLEGRINO ENRICO™ / *Enrico PELLEGRINO* / PELLEGRINO *Enrico* for valuable consideration, hereby expressly acknowledges, consents and agrees that the Trustee cannot and shall not, under any circumstances, nor in any manner whatsoever, be deemed to be a person with a function of accommodation, nor the guarantor of ENRICO PELLEGRINO™ / PELLEGRINO ENRICO™ / *Enrico PELLEGRINO* / PELLEGRINO *Enrico*.

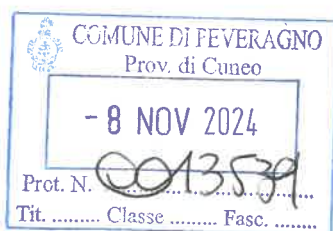
10) IDENTIFICATION-OF-THE-TRUSTEE.

- a) *Enrico Trustee Pellegrino* left his biological mother's womb and was physically delivered on this earth (live birth and still living) in CUNEO CN ITALY on 05/04/1976 K²⁶ as his own PERSONAL STATUS/Status of LEGAL Personality and in performing his duties as Trustee of the ASSETS-TRUST PELLEGRINO ENRICO™ segregating "ENRICO PELLEGRINO™" / "PELLEGRINO ENRICO™" and "*Enrico PELLEGRINO*" / "*PELLEGRINO Enrico*" is authorised to act as Trustee, Guardian and Curator, relieving *enrico* of interacting with Legal Orders, created *Ex nihilo, Ens legis, in Corruptio legis* which for this reason are prevented from interacting with the Pre-legal Entity, which is *enrico*. *Enrico Trustee Pellegrino*, in his express capacity is the guarantor, Trustee and administrator in a unique and exclusive form as Trustee, Individual protected under International Law, in the sole care and protection of the interests for the exclusive benefit of the individual, the individuals, human persons and "*enrico*", the sole and universal beneficiary(ies).
- b) *Enrico Trustee Pellegrino* holding full legal capacity and derived LEGAL Personality¹⁷, has full faculty and power to dispose and act in acts and contracts/agreements/deeds;
- c) The appointment of "*Enrico Trustee Pellegrino*" in his express capacity is enunciated in accordance with conventionally recognised international treaties.

11) STATE AUTHORITY, which includes legislative power, executive power and judicial power, as a result of the segregation of the legal positions in TRUST thus expressed "ENRICO PELLEGRINO™" / "PELLEGRINO ENRICO™" and "*Enrico PELLEGRINO*" / "*PELLEGRINO Enrico*", has been ANNULLED and has never taken place due to the "Birth Certificate" not having been correctly drawn up by the civil register office of CUNEO CN ITALY on 05/04/1976 K²⁶ Deed 389 Part 1 Series A/2, resulting in the ANNULMENT and NULLITY of the Deed itself and of all alleged legal liabilities (criminal, civil, administrative, objective, accounting, tax and disciplinary), pending and/or defined, wrongfully and abusively ascribed to the legal positions which are correctly restored and disposed in the TRUST for their sole ownership by the notifying settlor, and are in the sole trusteeship of *Enrico Trustee Pellegrino* Sole Owner of the name in TRUST "PELLEGRINO ENRICO™" segregating all positions pertaining to and disposed of in TRUST now known as "PELLEGRINO ENRICO™".

12) As far as parental responsibilities are concerned, contractual responsibilities for breach of contractual obligations and/or other atypical forms and non-contractual responsibilities, with the exception of justification, it is the right of *Enrico Trustee Pellegrino* to settle them according to the principle of moral responsibility.

13) As a result, the legislative and executive powers, for the protection of the interests of the legal positions in TRUST and in compliance with the restrictions deriving from all International Treaties, are incorporated in the Title as an expression of the autonomous legitimacy deriving from extraterritoriality, from the subjective point of view, of the TRUST, which can be established in a Foreign State, and these powers are exercised by *Enrico Trustee Pellegrino*, solely in exclusive trusteeship of the TRUST proclaimed "PELLEGRINO ENRICO™" invoking for the dissolution of any reserve "*Rebus sic stantibus*".



14) QUALITY, POWERS-AND-OBLIGATIONS-OF-THE *Trustee*.

The Trustee shall have capacity to sue and to be sued and can appear as Trustee before notaries, public officers, Solicitors and any public and/or private authority without them being able to object lack or indefiniteness of power.

- a. *The Trustee is subject solely to the purpose of the TRUST;*
- b. *the Trustee shall dispose of the assets of the TRUST within the limits of the TRUST's purpose, and without ever having to justify his conduct to anybody with the exception of the settlor and authorities recognised by his own jurisdiction;*
- c. *the Trustee has all the powers which are due to the owner in order to maintain, manage and even dispose of the assets arranged in the TRUST to achieve the purpose of the TRUST;*
- d. *if the assets of the TRUST include shares or stakes in companies, the Trustee will have no obligation to participate in their management or to appoint persons who participate in the administration of the company;*
- e. *the Trustee has, and exercises, in full power the capacity of Trustee, and Individual subject to protection in International Law, certifying the claim of LEGAL Personality (Section A);*
- f. *the Trustee is the only one who is entitled to act as Trustee, Curator, Attorney and Custodian of the legal positions and the Names in Trust "PELEGRINO ENRICO™" segregating legal positions and the Titles and Liens pertaining to the Name in TRUST as follows "PELEGRINO ENRICO™", "ENRICO PELEGRINO™", "PELEGRINO Enrico" and "Enrico PELEGRINO" as well as all their graphic extensions and / or inversions, strings and alphanumeric codes ascribable to them;*
- g. *the Trustee can amend the articles of association/statute and the nature of the TRUST only with the prior consent of the settlor;*
- h. *the Trustee is required to identify himself as such to third parties for any reason concerning the interests of the TRUST;*
- i. *the Trustee, in compliance with his legislation and at his own discretion, must maintain absolute confidentiality regarding the assets of the TRUST;*
- j. *in special cases of necessity and urgency identified at the discretion of the Trustee, it will be possible to temporarily disapply the statutory regulations without executing any specific formalities. Therefore the Trustee can consider himself and the people or objects dear to him as beneficiaries ~~Ad tempus~~ of the assets of the TRUST or of the assistance in which the purpose of the TRUST resides.*
- k. *the action of the Trustee in carrying out his functions shall be in conformity with the public order and morality of the host territory; in no case he shall be subject to the rules of Positive Law of other STATES existing and operating in the same geographical territory.*
- l. *In the performance of his duties, the Trustee shall endeavour to uphold the purpose of the TRUST and to preserve the integrity of the assets by refusing to consent claims that can be imposed on "PELEGRINO ENRICO™", "ENRICO PELEGRINO™", "PELEGRINO Enrico" and "Enrico PELEGRINO" by third parties and for any reason, purpose or cause whatsoever, by JURIDICAL ENTITIES, JURIDICAL PERSONS, JURIDICAL SUBJECTS.*
- m. *While it is not necessary at this time to keep a book of events, it is not excluded that at some time in the future this can be done, including the appointment of other guardians and other Trustees defining their functions and powers, such as successor powers as well;*
- n. *The list of powers of the Trustee set out in this deed is illustrative and not exhaustive.*

15) COMPENSATION-AND-REIMBURSEMENT-OF-EXPENSES-OF-THE-Trustee

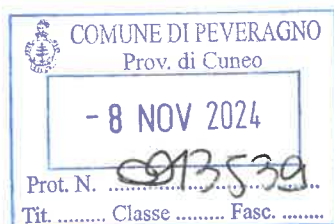
There shall be no compensation to the Trustee for the performance and exercise of his duties, but the Trustee shall be entitled to all reimbursements of expenses incurred and documented for the purpose of maintaining, managing and increasing the TRUST for the purposes set forth above.

16) BUSINESS-AND-ELECTIVE DOMICILE-OF-THE-TRUST.

17) GOVERNING LAW

Pursuant to Art. 6 of the Hague Convention of 2 July 1985, an explicit intention is expressed to adopt the law of Jersey (Jersey law) and subject only to it.



18) INITIAL-CONFERRAL-AND-SEPARATION-OF-ASSETS

- a) The assets of the TRUST include all the subjective legal situations, susceptible to economic evaluation, owned by the Trustee in respect of which he must fulfil the obligations of his office.
- b) In this STATUTE, the terms "TRUST" and "fund" can be interchangeable. It is hereby arranged the segregation of the assets in a TRUST (Articles 11 and 12 of the Hague Trust Convention 1985) and the transfer to TRUST "PELLEGRINO ENRICO™" in international jurisdiction of all the TITLES and BONDS ascribed to the legal positions in trust called: "PELLEGRINO ENRICO™", "ENRICO PELLEGRINO™", "PELLEGRINO Enrico" and "Enrico PELLEGRINO" and the Tax Code in TRUST PLLRNC76D05D205B™, as well as SSN 80380000100131349653 as the initial assets of TRUST "PELLEGRINO ENRICO™".
- c) Since the Assets are segregated in a TRUST, it subsists a perfect separation from the personal assets of the Trustee.

19) TRUST-INCOME

- a) The income of the TRUST in the comprehensive sense shall be understood to be any income, dividend, interest or any other benefit derived from the activities of the Trustee in the exercise of his functions, from the TRUST property or retained with licensed investment intermediaries which is used by the Trustee as an increase of the TRUST or for distribution to the various beneficiaries.
- b) In accordance with the will of the Trustee and the regulations of the statute, the assets or rights or obligations which anyone wishes to confer free of charge with the relative profits can form the income of the TRUST, taking into account art. 15 of the Vienna Convention which came into effect on 27 January 1980 for the countries that have joined, the income that can be constituted in the fund, once the costs and management fees to the TRUST have been settled/paid, can, under the control of the Trustee, be kept in the fund with a constant increase for a reasonable period of time, before it is transferred to the beneficiary/ies.
- c) The use of the income of the TRUST by the Trustee shall contribute to the pursuit of the purpose of the TRUST.

20) TRUST-ACCOUNT, GUARDIANS-AND-FURTHER-TRUSTEES, EVENT-BOOK, LETTER-OF-WISHES.

The Trustee, under terms and conditions to be established, can write a statement of the management of the trust/ TRUST to be exhibited to any investors and beneficiaries entitled thereto, containing such information as can be necessary to protect the trust/ TRUST, as well as the possible adoption of a letter of wishes.

21) ENTRY-INTO-FORCE, DURATION, REVOCABILITY-OF-THE-TRUST.

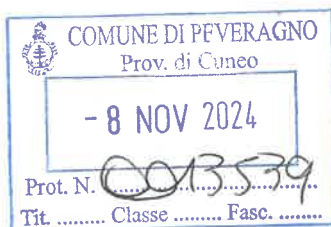
- a) The effect of this declaration is to give immediate notice of the past existence of the TRUST from the date of 6/4/1976 K²⁶ and that it has never ceased to exist, to arrest every past, present, future and immediate action of any third party outside the purpose of the TRUST and who has ever stipulated any alleged contract/agreement with the Trustee. Following the expressed will to adopt the international law known as the "Jersey Trust Law", it is hereby ratified that since the TRUST is under international jurisdiction, it is not and cannot be subject to any jurisdiction or administration in the Administrative/ Penal territory of any STATE including STATE ITALY or others without the prior consent of the Trustee.



24) SUPPLEMENTARY-NOTES:

- a) This declaration is presented as an advertisement of conscious knowledge and realisation of the Pre-legal "Status" of *enrico* and his highlighted faculties, and the purpose is to make this Deed public in order to protect others from illegal actions, which can involve remedial burdens, so it is ordered to be delivered for information to all *de facto* public and administrative OFFICES and all related Public Administration Bodies of the national and municipal territory.
- b) Taking action without providing any answer and/or making an exception of comprehensibility and/or declaring this document inadmissible means to give assent and validity to the motivation. - c) To avoid any misunderstanding: any reference by *Enrico - Pellegrino* / *enrico* to the Legal System in the EXECUTOR ITALY through ITALY REPUBLIC OF Guarantor, is not to be considered as consent (knowledge is not consent) to it; *enrico* Living and Beneficiary of the dynasty PELLEGRINO is a foreign, Pre-Juridical ENTITY, foreign to your jurisdiction, whether You invoke Positive State Law or Admiralty Law or any other Jurisdictional artefact.

25) LEGAL-CLARIFICATION NOTES:
